Restricted Bequest

You may also direct your gift to a favorite hospital, program or area you would like to support at Baystate Health.

Make a Gift through a Beneficiary Designation

Making a gift through a beneficiary designation provides increased flexibility and ease. This is a simple and straightforward way to support our lifesaving work. You may designate us as a beneficiary for a percentage or for a specific amount on the following assets.

- IRAs and other retirement accounts
- Life insurance policies
- Commercial annuities
- Bank or brokerage accounts

Here's three simple steps to name Baystate Health Foundation as a beneficiary:

1. Contact your retirement plan administrator, insurance company, bank or financial institution for a change-of-beneficiary form.
2. Decide what percentage (1% to 100%) you would like us to receive and name us, along with the percentage you choose, on the beneficiary form.*
3. Return the completed form to your plan administrator, insurance company, bank or financial institution.

Bank or Brokerage Accounts

Keep your bank account and/or brokerage account out of probate and make a meaningful gift to support Baystate Health by adding a transfer-on-death designation to Baystate Health Foundation to your account. Your bank or brokerage firm will add this free of charge. You retain full control of your account and can change the beneficiary if your circumstances change. Here's what to do:

1. Contact your bank or financial institution to set up a transfer on death (TOD) designation.
2. Decide what percentage (1% to 100%) you would like us to receive and name us, along with the percentage you choose, on the beneficiary form.*
3. Return the completed form to your bank or financial institution.
